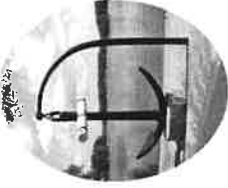

## **TOWN OF MINA October 21, 2023 SPECIAL ELECTION PROPOSED FORMATION OF THE FINDLEY LAKE SEWER DISTRICT PURSUANT TO ARTICLE 12-A OF THE NEW YORK STATE TOWN LAW**

### **PROCESS FOR VOTING BY ABSENTEE BALLOT**

The Town of Mina will accept absentee ballots under the following conditions:

1. All persons voting must be eligible to vote per the Rules of Voting.
2. It is a felony to make a false statement in an application for an absentee ballot, to attempt to cast an illegal ballot, or to help anyone to cast an illegal ballot.
3. To receive an absentee ballot, each person must complete a Town of Mina ABSENTEE BALLOT APPLICATION.
4. Town of Mina ABSENTEE BALLOT APPLICATIONS can be obtained on or after Monday, September 25, 2023 by making a request either by mail or in person from the Mina Town Clerk.
5. Phone or email requests will not be accepted.
6. If requesting an absentee ballot in person for someone other than yourself, you must have a written request signed by the person who is requesting the ballot and a copy of a valid photo identification that includes that individual's signature.
7. If requesting an absentee ballot by mail, the completed ABSENTEE BALLOT APPLICATION must be received by the Town Clerk by Tuesday, October 10, 2023 to allow time for the absentee ballot to be returned to the property owner so that the property owner can complete the ballot and mail it back to the Town Clerk with a postmark of October 21, 2023 or before.
8. All completed absentee ballots must be accompanied by a copy of a valid photo identification that includes the individual's signature.
9. Absentee ballots that are returned in person must be returned before the close of in-person voting on October 21, 2023 and must be accompanied by a copy of a valid photo identification that includes the individual's signature.
10. The Town Clerk will place all absentee ballots in a locked box for County Election Officials to open and count.
11. Absentee ballots received by October 21, 2023 will be opened and counted by County Election Officials at the close of in-person voting.
12. Absentee ballots that are returned by mail will be counted at by the County Board of Elections the week of October 30, 2023 if they are post marked by October 21, 2023 and received at the Town Clerk's Office by October 28, 2023.
