1.0 AUTHORIZATION

On February 10, 2022, the Town of Mina retained the services of Barton & Loguidice, D.P.C. (B&L) to prepare this Map, Plan, and Report for the Findley Lake Sewer District in accordance with Article 12 of New York State Town Law.

2.0 BACKGROUND

Findley Lake, located in the Town of Mina, is a NYSDEC Section 303d/TMDL impaired waterbody. The water quality impairment has largely been attributed to inadequate, on-site wastewater treatment systems along its densely developed shorelines. A 2008 NYSDEC/USEPA "Total Maximum Daily Load (TMDL) for Phosphorus in Findley Lake Report," estimated that about 45% of the Lake's current phosphorus loading comes from nearby septic systems and stated that implementing a public sewer system around Findley Lake is an absolutely essential first step toward stopping the degradation of the lake's water quality. In an effort to protect the water quality in Findley Lake, the Town of Mina is seeking to form a municipal sanitary sewer district and install a sanitary sewer collection system and wastewater treatment plant to treat wastewater around Findley Lake. This Map, Plan and Report outlines the project, district boundary, and associated costs for the proposed Findley Lake Sewer District to serve as the basis of district formation in accordance with Article 12 of NYS Town Law.

3.0 EXISTING FACILITIES

Currently, properties along Findley Lake utilize privately owned, on-site wastewater treatment systems (OWTSs). The small lakeside lot sizes and soil conditions are not conducive to the use of OWTSs and have been identified as a major cause of the degradation of water quality in Findley Lake. It is suspected that the majority of the OWTSs do not work appropriately, are in need of replacement, or are not compliant with current standards. Implementing a public sewer system around Findley Lake is a high priority for the USEPA, NYSDEC, Chautauqua County, and the Findley Lake Watershed Foundation. Harmful algal blooms (HABs) regularly occur in Findley Lake, attributed in large part to failing on-site septic systems within the lake's watershed. When septic systems fail they release bacteria and oxygen consuming nutrients which can degrade the quality of water, cause excessive algae growth, and render the water unsafe to drink or for recreational (contact) use. A municipal sanitary sewer system would reduce the nutrient loading to Findley Lake and is critical to begin improving the water quality of the lake.

4.0 PROPOSED DISTRICT BOUNDARY AND EQUIVALENT DWELLING UNITS

A map of the proposed Findley Lake Sewer District boundary is shown on Figure 1. A written legal description of the proposed district boundary is included in Appendix A. A parcel list of the proposed sewer district, including an EDU assessment schedule, is included as Appendix B.

An equivalent dwelling unit or EDU is the unit of measure by which a user is charged for sewer services. In general, all single-family residences (year round and seasonal) were measured as one (1) EDU, multifamily residences and residential properties with apartments were measured as one (1) per dwelling unit, vacant buildable properties were measured as 0.5 EDUs, and commercial properties were measured based on size and usage. Vacant properties will only be charged for sewer debt service and not for annual operation and maintenance costs. Developed properties will be charged for both sewer debt service and annual operation and maintenance costs. Based on the EDU schedule in Appendix B and the Findley Lake Sewer District boundary, the sewer district would currently contain an estimated 403.7 equivalent dwelling units. Of the estimated 403.7 EDUs, vacant parcels would make up 10 EDUs, while developed parcels would account for 393.7 EDUs. The number of EDUs in the sewer district is subject to continuously change.

5.0 PROPOSED FACILITIES

A detailed comparison of potential sanitary sewer collection and treatment facility alternatives was performed in the June 2022 Findley Lake Sanitary Sewer District Study Preliminary Engineering Report (PER). This section provides an overview of the alternative from the PER selected by the Town Board to be included in this Map, Plan, and Report.

5.1. Collection System

The proposed sewage collection system is a hybrid collection system consisting of both traditional gravity sewers and low pressure sewers. Gravity sewers would generally be installed to service the downtown commercial and residential area located at the north end of Findley Lake and other densely populated locations around the lake with favorable topography conducive to gravity sewers. For all other areas, low-pressure sewer infrastructure would be utilized. The collection system would approximately require the following collection system infrastructure:

- 11,000 LF of 8-inch Gravity Sewer Main
- 68 Manholes totaling 450 VLF of Manhole
- 159 Gravity Sewer Connections
- 8,650 LF of 6-inch Sewer Laterals
- 9 Centralized Wastewater Pumping Stations
- 6,000 LF of 8-inch HDPE Pressurized Sewer Main
- 7,500 LF of 6-inch HDPE Pressurized Sewer Main
- 8.100 LF of 4-inch HDPE Pressurized Sewer Main
- 6,100 LF of 3-inch HDPE Pressurized Sewer Main
- 3,400 LF of 2-inch HDPE Pressurized Sewer Main
- 27,100 LF of 1.25-inch HDPE Low-Pressure Sewer Lateral
- 195 Simplex Grinder Pumping Stations
- 30 Force Main Valves and 50 Force Main Cleanouts
- 10 Air/Vacuum Release Manholes
- Two (2) Odor Control Stations

The project would include the installation of all public infrastructure. Existing private infrastructure connections to newly installed public infrastructure will be the responsibility of each property owner. In areas of gravity sewers, service laterals would be installed to within 10 to 25 feet of an existing structure or an existing structure's on-site treatment system. Service laterals would generally not extend past the side of the house that fronts the public sewer main. In areas of low pressure sewers, the capital improvement project will provide one (1) grinder pump to each developed parcel, install the grinder pump electrical panel, and connect the electrical panel to the grinder pump, but will not connect the panel to structure/site power. Where space is limited or it is fiscally advantageous, shared grinder pump basins may be utilized. Generally, sewer laterals that connect to the grinder pumps would be installed to within 10 to 25 feet of an existing structure or an existing structure's on-site treatment system. Property

owners will be responsible for connecting their existing facilities to the new gravity lateral or grinder pump sewer lateral, powering the grinder pump electrical panel with site power, and decommissioning their existing septic tank or OWTS.

5.2. Wastewater Treatment Plant

The sewer district's Wastewater Treatment Plant (WWTP) is projected to be located on vacant land just north of Findley Lake and Interstate-86 and is estimated to discharge into the West Branch of French Creek. The proposed WWTP will generally consist of the following main infrastructure:

- Headworks and grit removal infrastructure
- Sequencing Batch Reactor (SBR) biological treatment tanks and associated treatment infrastructure
- Biological phosphorous removal facilities (if required by NYSDEC)
- Effluent Filtration (if required to meet final NYSDEC permit limits)
- Ultraviolet effluent disinfection equipment
- Anaerobic digestion tanks and associated infrastructure
- Mechanical solids dewatering and disposal facilities
- Site piping and wastewater outfall
- Building(s) to house various equipment and an office/lab
- Emergency power system
- Plant monitoring/alarm systems
- Site/Civil improvements (driveway, site lighting, parking area, fencing, etc.)

6.0 PROJECT COST AND FINANCING

The estimated capital cost of the proposed facilities outline in Section 5.0 is \$26,100,000. Refer to Appendix C for an itemized cost estimate. The maximum amount to be expended for the Town of Mina for the Findley Lake Sewer District is \$26,100,000.

6.1. Estimated Project Debt Service

The annual project debt service charge for the construction of the sewer system will largely be dependent on the project's final grant and loan funding package. Based on four (4) plausible funding scenarios, debt service costs are estimated to be between \$322 and \$1,288 per EDU per year.

6.2. Estimated Annual Operation and Maintenance Charges

The estimated annual operation and maintenance (O&M) charges for the proposed project is \$761 per EDU based on an estimated annual sewer budget of \$300,000. Inclusive in the sewer budget is the yearly estimated cost of labor, equipment, utilities, chemicals, materials, and short lived asset reserve savings required to operate and maintain the system. Actual O&M costs will fluctuate on a year-to-year basis, but generally increase at a similar rate to inflation.

6.3. Total Estimated Annual Use Cost

The total estimated annual user cost, inclusive of debt service and estimated O&M costs, is anticipated to range from \$1,083 to \$2,049. Final user costs will be calculated by the Town and are dependent on final project costs and the funding received.

7.0 IMPLEMENTATION

It is recommended that the Town of Mina Town Board proceed in accordance with NYS Town Law for district formation, generally to include the following:

Findley Lake Sewer District Boundary Map






























Figure 2 Findley Lake Sewer District Proposed Facilities Map

- Seasonal Residence = 1 EDU

VACANT LAND:

Buildable as determined by Town Code

- Buildable Vacant Land = 0.5 EDU
- Unbuildable Vacant Land = 0 EDU

PROPERTIES WITHOUT WATER/SEWER USE:

Properties will be treated as vacant land with the following exceptions:

- Public Services (substation, telephone, utilities, etc.) with no sewer = 0 EDU
- Public Service (substation, telephone, utilities, etc.) with sewer = 1 EDU Minimum; more as determined by Town Board

COMMUNITY SERVICES:

- Churches = 1 EDU Minimum; more as determined by Town Board
- Municipal Buildings = 1 EDU Minimum; more as determined by Town Board
- Park/Cemetery with Sewer = 1 EDU Minimum; more as determined by Town Board
- Park/Cemetery without Sewer = 0 EDU
- Schools = 1 EDU Minimum; more as determined by Town Board

COMMERCIAL, RECREATIONAL, INDUSTRIAL:

- Hotels, Inns, Lodges Boarding Rooms, etc. = 1 EDU + 0.25 EDU per room
- Campground = 1 EDU + 0.10 EDU per campsite

METERED PROPERTIES:

Properties assessed at more than one EDU have the option to meter use. Metered assessments will be based on the following:

- EDU Assessment Based on Water Meter
 - o 1 EDU Per 12,500 gallons of quarterly water use (Minimum of 1 EDU)
- EDU Assessment Based on Sewer Meter
 - o 1 EDU Per 10,000 gallons of quarterly sewer use (Minimum of 1 EDU)
- Requirements:
 - Meter purchase, installation, service, testing, and replacement expenses are the responsibility of the Property Owner
 - Meter type and location will require Town of Mina of approval. Meter installation will require an
 inspection performed by the Town of Mina prior to approval for use.
 - o The Town of Mina has the right to reject the use of meter assessments if accuracy is in question.
 - The Town of Mina can require the property owner to replace a meter or test its accuracy as deemed necessary to ensure a fair EDU assessment.
 - Failure to meet the above requirements will result in an EDU assessment as determined by the Town Board.
